## **Project Proposal Application**

Applications are accepted on a rolling basis and reviewed quarterly. Please review the <u>Art in the Parks Program</u> <u>FAQs</u> and <u>Criteria</u> documents before submitting your application.

Proposed art works will be evaluated using the following guidelines and criteria:

## Guidelines

- Projects should engage visitors and enhance their experience and understanding of park resources
- Projects should highlight or draw attention to a unique aspect of the area
- Projects will occur within the Park and be temporary in nature (one year or less), with the exception of projects that are designed to be more permanent such as within visitor centers
- Projects should have minimal/no negative impact on natural and cultural resources
- Projects should be innovative in their fabrication approach and materials should be recycled or reusable afterward whenever possible
- Projects should be highly sensitive to accessibility and safety issues as they relate to visitors and staff

## **Selection Criteria**

- Artistic merit
- Community involvement opportunities, either in the creation or enjoyment of the work
- Project relevance
- Appropriateness for National Park setting with minimal to no impact on visitor access during installation and de-installation
- Availability of resources
- Durability and maintenance
- Safety, security and access
